KING COUNTY HEN PRIORITIZATION

- Currently serving all HEN and ABD clients, prioritized based on intake slots and targeted prevention tool (ABD expansion grown by 26% in last 2 months) current active just over 1,600
- Considering
 - Prioritization based on HEN vs ABD enrollment
 - Homeless vs At Risk
 - Prioritization based on VISPDAT score
- How to triage
 - Waitlist
 - Call in (first come first served)
 - Enroll based on exit numbers (have seen exits go down last two months)

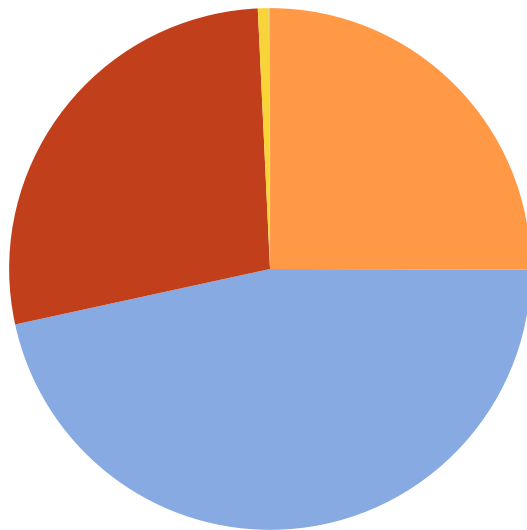

ABD CLIENTS HOMELESS VS. HOUSED

- 20,064 clients on ABD June 2016
- 6,759 client on HEN June 2017

ABD Housing Status



- Housing instability
- Couch surfing
- Homeless
- Shelter

For those stably housed, about 10% were in subsidized units



KING COUNTY COORDINATED ENTRY SYSTEM

- Currently completing VISPDAT for all clients and referring directly to community queue
- Considering
 - Better integration to access other resources available to clients through this process (diversion, rapid re-housing, public housing)
 - Unknown: will ABD clients score higher on the VISPDAT than HEN?



KING COUNTY FOUNDATIONAL COMMUNITY SUPPORTS (FCS)

- Currently organizing FCS under in-house mental health program.
 - Carving out 1 day per week for employment specialist to work for supportive employment.
 - Hiring 2 full-time staff to work with housing location/support, figuring 14-16 case load. Will also work with clientele directly from mental health programs not associated with HEN/ABD.
 - Challenges: limited case management per person, no startup funding available, low reimbursement rate, 5 year demonstration.
